- No more than four passengers per vehicle
- Golf carts must have headlight kits if used at night
- No driving while intoxicated or with open alcohol containers
- No golf carts are permitted on the lake grassed areas or fields
- Golf carts to be parked in assigned parking areas only when using the pavilion or lake

## GOLF CART RULES AND REGULATIONS

---

- Operator must have a valid driver's license
- All drivers/owners must have liability insurance on golf cart
- Drivers must obey MSLA speed limit of 5 MPH
- No driving while intoxicated, or you will lose your privilege to have a golf cart at MSLA
- No night driving without a headlight kit
- No more passengers than seating permits (maximum 4)
- All passengers should be sitting, absolutely, no standing while in motion
- Site number must be prominently displayed on two sides of golf cart with MSLA registration sticker
- Violation letters will be sent to site owners for failure to comply with golf cart rules and regulations:
  - The first violation is a warning,
  - The second violation will impose a fine
  - The third violation will revoke permission to own and operate a golf cart at MSLA
